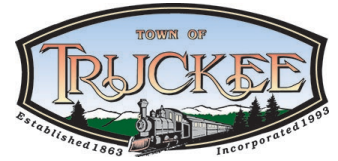




Town of Truckee Mandatory Recycling & Organics Collection Waiver



All businesses and multi-family residential dwellings of five or more units in the Town of Truckee must comply with State-mandated requirements to divert recyclable and organic waste from landfill (Town of Truckee Municipal Code Sections 6.01.060 and 6.01.070).

Under Town of Truckee Municipal Code Section 6.02.085, the Town may issue a waiver to comply with some or all of these requirements if the business or multi-family dwelling provides documentation of the following circumstances:

- **De Minimis Waiver:** Businesses and multi-family dwellings that generate a limited amount of organic waste may apply for a de minimis waiver if they meet the following thresholds:
 - **For Food Scraps:**
 - Generate 2 or more cubic yards of solid waste per week and less than ½ cubic yard of food scraps per week. (Businesses generating less than 2 cubic yards of solid waste per week and multi-family dwellings are not required to have food scraps collection.)
 - **For Yard Waste:**
 - Generate 2 or more cubic yards of solid waste per week and less than 20 gallons of yard waste per week (May-November); or
 - Generate less than 2 cubic yards of solid waste per week and less than 10 gallons of yard waste per week (May-November).
- **Physical Space Waiver:** Businesses and multi-family dwellings that lack space for separate or additional recycling, food scraps, or yard waste containers may apply for a physical space waiver.

Please complete this application to obtain a waiver from compliance. Staff will review the application to determine if the business meets the eligibility criteria for the requested waiver type.

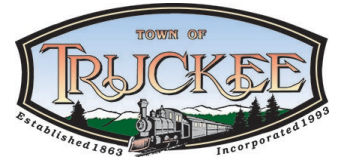

I understand that, if granted, this waiver expires five years from the approval date and accept that it is my responsibility to apply for a waiver renewal 30 days prior to the expiration date.
